### GENERAL TERMS AND CONDITIONS FOR REGISTRATION AND PARTICIPATION

These provisions set out the conditions under which a company may register and then participate as an exhibitor (hereafter referred to as the Exhibitor(s)) in the next ESPRITMEUBLE Trade Fair (hereafter referred to as the Tshibitor(s)) in the next ESPRITMEUBLE Trade Fair (hereafter referred to as the Trade Fair) which will be held from Saturday, 18 Nouember 2022 at 09:00 to Monday, 21 Nouem-ber 2022 at 18:00, in Paris, Porte de Versailles, Hall I. These provisions also define the obligations incumbent on both Exhibitors and ESPRITMEUBLE, the organiser of the Trade Fair and its dedicated beam (hereafter the Trade Fair Organisation).

### ARTICLE 2 - METHODS OF REGISTRATION FOR THE TRADE FAIR 2.1-Participation application

2.1-Participation oppucation
Firstly Exhibitors fill in a participation application form (hereafter known as the Form) which is accessible online on the Trade Fair website, www.
ESPRITMEUBLE.com. On this Form they fill in the information about their company, the contact details for the contacts dealing with the Organisation, the brands represented by attaching a logo and the characteristics they want for their stand. Then they must confirm these general conditions, profit in the contact that th tney want for their stand. Inen they must confirm these general conduct certifying that they are aware of the amount that must be paid for the application fees, the rental prices, and the payment schedule for their participation. They then confirm their participation application and pay the application fees by bank transfer after receiving the invoice. Finally, they will receive an email from the Trade Fair Organisation acknowledging receipt of their participation application and the payment of the application fees application fees.

2.2-Confirmation of participation

2.2-Confirmation of participation
Any participation in the Trade Fair by an Exhibitor is subject to the prior agreement of a Selection Committee which will rule on the basis of the content of the Exhibitor's Form, the attached documents and/or on the basis of their own reasons. Each Exhibitor will be notified of the decision of the Selection Committee by all written means. The Committee may confirm or reject participation in the Trade Fair without having to justify a rejection. The decision of the Selection Committee authorising participation results in the obligation for the Exhibitor concerned to be subject to the content of

in the obligation for the Exhibitor concerned to be subject to the content of these general conditions and the instructions in the Technical Guide in the framework of its participation in the Trade Fair. The decision of the Selection Committee to reject participation cannot be contested by the Exhibitor concerned, or entail the responsibility of the Trade Fair Organisation for any reason whatsoever. In addition, the Organisation will retain all the application fees paid by the Exhibitor, the participation of which has been rejected by the Selection Committee, i.e. €200 exc. tax without the Exhibitor being able to demand reimbursement.

2.3-Surface area allocated
The Trade Fair Organisation will allocate to each Exhibitor confirmed by the Selection Committee a stand surface area and a location compliant with the special characteristics that the Exhibitor has expressed on its Form with the special characteristics that the Exhibitor nas expressed on its Form (bore surface, one or more corners and all other comments on this subject, etc.). The Exhibitor acknowledges being fully in agreement with the Trade Fair Organisation concerning the Stand surface area which it entered on its Form. Indeed, the total amount invoiced will be accludated by the Trade Fair Organisation on the basis of the maximum surface area indicated by the Exhibitor to ten percent more or less. In these conditions the Exhibitor can exist mentally account the information and the properties of the conditions the Exhibitor. can neither modify nor contest this information relating to the surface area of its stand after having filled in, confirmed and validated its Registration
Application Form online.

ARTICLE 3 – METHODS FOR PARTICIPATION IN THE TRADE FAIR
3.1 Allocation and distribution of stands
The Selection Committee will be responsible for the allocation and distribution of stands between the various Exhibitors for which it has confirmed their tion of stands sequent the unious Exhibitors for which it has confirmed in participation. As for as possible the allocation and distribution of stands will match the wishes of the Exhibitors expressed on their Forms to within roughly 10%. This will be done within the limit of the space still available for the Trade Fair and will also take into account the technical, logistical and safety constraints to be adhered to in the context of occupation of the location of the stand.

The Trade Fair Organisation will inform Exhibitors by all written means of the final surface area and location of the Stand which will be allocated to

The latter may cover one or more advance payments in relation to the date of confirmation of their registration by the Committee (see Article 4). For reasons inherent in the smooth running of the Trade Fair, the Trade Fair Organisation reserves the right:

- To grant automatically or not grant an Exhibitor one or more corners on its
- la grant automatically or not grant an Exhibitor one or more corners on its Stand, notwithstanding the wishes expressed on its registration form,
   To insist on the presence of a post for an Exhibitor, the surface area of which will be deducted from the final cost of the Exhibitor's participation in compliance with Article 4 of these general sales conditions.
   In all three cases, the Exhibitors therefore agree to bear the material, logistical, financial and other consequences related to these modifications without contest.

### 3.2 Occupation of stands

  \* To fit out their stands in compliance with the specific characteristics anticipated in the plan which they provided to the Organisation for prior validation from the point of view of safety rules

  \* To cover all the metal structures they may use to assemble and fit out

- with regard to the fitting out, assembly, use and dismantling of their stands, to adhere to the material, logistical and sofety instructions stated in the Trade Fair Technical Guide which they will be invited to download later on request from the Trade Fair Organisation
- To comply strictly with the special instruction relating to the stand locations To comply strictly with the special instruction returning to the stand accuration of control prices the main aiset, the horizontal safety aiset, the vertical safety aiste separating ESPRITMEUBLE and ESPRITSOMMEIL as well as the living areas of the Trade Fair (reception, village square, catering points), which must have a minimum opening in the front of the stand of 70% of their width.
   To adhere strictly to the schedules imposed by the Organisation concerning the Trade Fair phases of assembly, use, and dismantling.

### 3.3 Insurance

The provision of a stand obliges Exhibitors to take out an all risks exhibition The provision of a stand obtiges Exhibitors to take out an all risks exhibition insurance policy which will be invoiced to them at a price of one Euro per square metre occupied. The purpose of this insurance is to cover damages incurred by the material presented on the stand in case of material loss, deterioration or damage such as fire, explosion, water damage, theft, act of terrorism or sabotage, strike, or riot. The details and the methods of cover for this insurance will be notified to the Exhibitors through the Technical Guide this insurance will be notified to the Exhibitors through the Technical Guide which they will be given later. Furthermore, parallel to this insurance, Exhibitors must also have personally taken out a third party liability insurance with a company known to be solvent. This insurance must guarantee them against the financial consequences of their responsibility under common law, due to bodily, material and immaterial damages, which their employees or they themselwes may cause directly or indirectly to third parties in the context of their activity. Exhibitors must be able to provide a certificate for this insurance at the first request by the Organisation.

The price to be paid by Exhibitors includes the rental, namely the surface area Interprice to be point of perinter that the process of the stand which has been granted to them by the Trade Foir Organisation after confirmation of their participation by the Selection Committee. It is a bare surface (without partitions, carpet, electricity, etc.) ready to be fitted out by Exhibitors, and calculated in square metres. Depending on the date of registration for the Trade Fair, each Exhibitor has the following price/m² exc. tax applied:

- Up to 31 Dec. 2021: £197/m² exc. tax

- Food 4th excelled 31 Meets £201/m² exc. tax

- From 1st January to 31 March: €209/m² exc. tax From 1st April to 30 June: €229/m² exc. tax

• From 1st July. E249/m² exc. tax In addition to the prices/m² exc. tax for the bare surface occupied, the price to be poid by Exhibitors also includes the application fees and the costs related to the presence of corners on their stand, the Service Pack and Marketing Pack.

### 4.2 Methods of payment

Each scheduled payment will give rise to the issuing of an invoice by the Trade Fair Organisation. The price mentioned on the invoice will include the VAT rate in force on the day it was issued. Each invoice will then be sent to the Exhibitors concerned for payment. In principle these invoices are payable on receipt and at the latest, as an exception, before the due date set in the above table. In a trade Fair Organisation reserves the right to require from Exhibitors simultaneous payment of several scheduled payments if the date of their registration and confirmation of their participation by the Committee justifies it in relation to the above-mentioned payment schedule. ### 4.3 Sanctions

4.3 Sanctions
Access to the Stand by Exhibitors is conditional on the payment in due form by them of invoices issued by the Trade Fair Organisation for each scheduled payment. Consequently the Trade Fair Organisation reserves the right:
To charge Exhibitors on their balance invoice a financial penalty representing 10% of the amount of the scheduled payment for which a payment delay of

- 10% of the amount of the scheduled payment for which a payment delay of more than 10 days after the planned payment date is noted.

   To cancel and/or block Exhibitors from participating in the Trade Fair in the case of non-payment of its invoices and/or repeated excessive delays in payment of these invoices. In this case the Trade Fair Organisation util retain all the payments (advance payment and other invoices) already paid by the Exhibitors concerned. These payments will be deemed to be definitively acquired by the Trade Fair Organisation and cannot be the subject of any reimbursement. In addition, Exhibitors will also be required to pay the invoices that they have not paid and which will have been issued but the Trade Fair Organisation before the detay upon which will have been issued by the Trade Fair Organisation before the date upon which the latter will have decided to block and/or cancel their participation.

### 4.4 Cancellation

Any Exhibitor wishing to cancel its participation in the ESPRITMEUBLE Trade Fair must notify the Organisation by all written means that can be dated. For the Exhibitor this cancellation will give rise to the obligation to bear the

  Depending on the date accepted for the notification, the sum for the cancellation fees in relation to the price of the rental will be calculated:

These cancellation fees will be increased by 15% as compensation These cancellation fees will be the subject of a standalone invoice from the Trade Fair Organisation. The Trade Fair Organisation will deduct from the price of this invoice the sum of the payments already made by the Exhibitor until the date of receipt of the written document by which the latter notified the cancellation

**4.5 Early or late dismantling**Exhibitors are required to dismantle their stands at the time set for this by the ESPRITMEUBLE Trade Fair Organisation in the Technical Guide provided for

**4.5.1. Early dismantling**Should the Trade Fair Organisation observe early dismantling of the Stand by the Exhibitor, a penalty for not adhering to the set times of a sum of one thousand fine hundred Euros excluding tax (£1500 exc. tax) will be invoiced to the Exhibitor

**4.5.2. Late dismantling**Euery hour that the Exhibitor retains a Stand beyond the set time will be invoiced to the Exhibitor at a price of one thousand five hundred Euros excluding tax (E1500 exc. tax).

If the retention of this stand blocks the general dismantling of the Trade Fair, the

Trade Fair Organisation reserves the right to entrust the dismantling of this stand to its teams. This operation will be invoiced to the Exhibitors by the Trade Fair

- to its teams. This operation will be invoiced to the Exhibitors by the Irade Fair Organisation in the following manner:
   One thousand six hundred Euros exc. tax (E1600 exc. tax) for dealing with the dismantling of the Stand by the Trade Fair Organisation teams
   Three hundred Euros exc. tax (E300 exc. tax) per ton of stand cleared by the Trade Fair Organisation Teams.

For the duration of this operation the Trade Fair Organisation will also apply the hourly rate for the additional occupation of the above-mentioned stand. In no circumstances will the Trade Fair Organisation accept liability when it dismontles, or even destroys if necessory, a stand in the conditions stated above. Exhibitors therefore waive all rights to proceedings against the Trade Fair Organisation.

The costs mentioned in this article will be the subject of standalone invoices from the Trade Fair Organisation to the Exhibitors concerned. These invoices will be added to those relating to exhibitors' participation.

The Exhibitors authorise the Trade Fair Organisation to issue communica-tions about their presence on the Trade Fair website and social networks tions about their presence on the Trade a fair usesite and social networks using the logos for their represented Brand(s) in accordance with the indications and graphics charter supplied to them previously. In return, the Trade Fair Organisation will provide Exhibitors with the ESPRITMEUBLE graphics charter so that they can use the Trade Fair logo on their internal communication media, social networks or in the press. The use of the respective logos will stop on 31 December of the year of the Trade Fair

concerned.

Exhibitors are prohibited from promoting their brand(s) within the Trade
Fair enclosure and outside the surface area of their stand in any way whatseever and by any means whatsoever. Communal areas are reserved for
the promotion of the Trade Fair in its entirety. Exhibitors will be responsible
for the music rights if they intend to broadcast music on their Stands.
By participating in the Trade Fair, Exhibitors implicitly authorise the Organication to use the participation in the Trade. say but cipiting in the Trade Pair, Exhibitors implicitly authorise the Originisation to use the portrait rights of all their employees present at the Trade Fair. As such, the Organisation may take any videos and/or photographs representing these employees for the purpose of using their image on any commercial and media promotions medium for the Trade Fair. However, Exhibitors retain the potential to refuse the use of images of their employees by sending the relevant email to camille.bouillot@ ESPRITMEUBLE.com.

### ARTICLE 6 - RESPONSIBILITY

The service provided by the Trade Fair Organisation is limited to supplying Exhibitors with a bare stand surface area (without partitions, carpet, electricity, etc.) ready to be fitted out by Exhibitors. Consequently, the Trade Fair Organisation accepts no responsibility towards all Exhibitors in relation to:

the possible rejection of their participation as decided by the Selection the possible rejection of their participation as decided by the Selection Committee, the consequences of all types linked to assembly, fitting out, layout and use of stands neighbouring that of each Exhibitor, it being understood that the task of the Trade Fair Organisation is limited to con-trolling all the stand plans from the point of view of safety rules alone. The attendance and the footfall at the Trade Fair by visitors, it being under-stood that the Trade Fair Organisation, under its obligation of means, will do everything possible to ensure good visibility in terms of promotion and communication. Furthermore, Exhibitors are informed that the sanctions and other financial consequences provided for in these documents, and and other financial consequences provided for in these documents, and

and other financial consequences provided for in these documents, and implemented by the Trade Fair Organisation against Exhibitors cannot be the subject of any dispute on their part.

Should cancellation of the Trade Fair be decided by the Trade Fair Organisation following the occurrence of a case of force majeure, Exhibitors will not receive any damages because of this and will be informed of the new organisation methods as soon as possible.

Cases of force majeure include those accepted by French law in force on the day of the validation of the Exhibitor's Participation by the Selection Committee, as well as any new health, climatic, economic, political or social situations, on a local, national or international Level, which are unforeseable, independent of the Organiser's will, and which make it impossible to hold the Trade Fair or which entail risks of disturbances or disorders likely to affect its Corponisations seriously and its smooth running. disorders likely to affect its Organisation seriously and its smooth running

or the safety of property and people.

The occurrence of a current epidemic (linked to COVID-19) will constitute a case of force majeure.

These cases also include events making it impossible to use the Trade Fair location, listed below in a limited way:

- Fire, explosion, flood and thunderstorms,

- Decision by VIPARIS, the lessor of the site, an administrative authority to

- close or requisition the Trade Fair Location.

In case of cancellation:
In case of cancellation of the 2023 Trade Fair by the organisation for health reasons, ESPRITMEBLEE will keep only 10% of the deposit corresponding to the first 2023 advance payment. This amount will automatically be carried over to the 2024 Trade Fair and will register the exhibitor's participation in the next edition. The 2023 application fees are deemed to be acquired and other advance payments will be refunded on first demand.

ARTICLE 7 – PROTECTION OF PERSONAL INFORMATION

Personal information collected on the registration form is recorded in a digital file by ESPRITMEUBLE for the management of its exhibitor files. They are kep for 2 (two) years and is intended for its Soles Department. The personal information collected on this form may be communicated to ESPRITMEUBLE partners or service providers. In compliance with the French Data Protection Law, any physical person has the right of access to, correction, cancellation, and deletion of and the portability of data concerning him/her. ### ARTICLE 8 - APPLICABILITY

ARTICLE 8 - APPLICABILITY
These provisions stole all the obligations required of Exhibitors in the context of their registration and/or participation in the Trade Fair. For this reason, they govern Exhibitors' registration for the Trade Fair, as well as the allocation, provision, fitting out, assembly, use and dismantling of their respective stands. Exhibitors therefore acknowledge the full authority and superiority of these conditions over those they could uphold to the Trade Fair Organisation. Any dispute arising from the registration and/or participation of Exhibitors in the Trade Fair, and from the interpretation and implementation of these conditions must firstly be the subject of an attempt at amicable resolution. To do this the Exhibitors and the Trade Fair Organisation will rely on all the documents stating their respective obligations, it being understood that only the most recently dated will prevail. If there is no amicable agreement, the disputes will be resolved under French Law and will be brought before the French Courts recognised as being the only competent courts by the Exhibitors.
